1. FOLLOWING IS STATION'S TRANSLATION OF CKSPHERE'S OPS NOTE. WHILE THE ESSENCE OF THE TRANSLATION IS UNDOUBTEDLY CORRECT, [REDACTED] MAY BE ABLE TO OBTAIN EVEN MORE FROM THE NOTE. IT IS PAINFULLY OBVIOUS, HOWEVER, THAT CKSPHERE CONSIDERS HIMSELF TO BE IN GREAT DANGER AND HIS SECURITY SITUATION CONTINUES TO DETERIORATE.

[REDACTED] DESCRIPTION OF CKSPHERE AT THE MEETING IN NO WAY RESEMBLES THE IMAGE ONE RECEIVES OF THE AUTHOR OF THESE NOTES. WE LOOK FORWARD TO HEADQUARTERS FULL TRANSLATION OF THE NOTES; WE ARE CERTAIN YOU WILL BE AS STUNNED AS WE ARE AFTER YOU READ IT. STATION COMMENTS WILL FOLLOW TOMORROW.

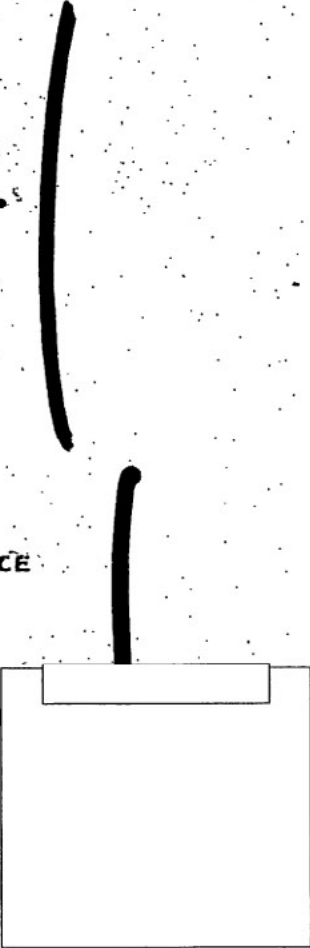
2. FOLLOWING IS STATION'S TRANSLATION OF NOTE:

1. TEXT OF NOTE PREPARED FOR 20 SEP 83 MEETING:

1. IN THE END OF APRIL OF THIS YEAR EVENTS TOOK PLACE THAT, AS A RESULT, CAUSED ME TO STOP MY ACTIVITY IN COMPILING AND PHOTOGRAPHING MATERIALS.

IN MARCH 1983, I PASSED YOU PART OF THE INFORMATION ON THE AIRCRAFT TARGET RECOGNITION SYSTEM WHICH IS EMPLOYED ON THE AIRCRAFT MIG -29 WITH "RLS NO19."

IN APRIL, UPON MY REQUEST, YOU RETURNED TO ME A COPY OF THESE MATERIALS. 26 APRIL, AT 9 O'CLOCK IN THE MORNING, THE HEAD DESIGNER

KIRPICHEV* CALLED ME IN TO DISCUSS ROUTINE QUESTIONS. DURING THIS DISCUSSION THE TELEPHONE RANG; "KIRPICHEV" ANSWERED THE PHONE AND AFTER SEVERAL MOMENTS ASKED, SPEAKING WITH HIM OVER THE PHONE:

- FOR WHAT PURPOSE DO YOU NEED THIS. ("NAUZA")...
..... VERY WELL, I'LL DO IT.

AFTER THIS TELEPHONE CALL HE SUMMONED THE LEADING ENGINEER, WHO IS IN CHARGE OF QUESTIONS ENTAILING THE "RLS NO19" WITH THE RECOGNITION SYSTEM, AND TOLD HIM THE FOLLOWING:

KIRPICHEV: "BALAN" JUST CALLED AND ASKED THAT BY THE END OF THE DAY I PASS HIM A LIST OF PERSONS FAMILIAR WITH THE RECOGNITION SYSTEM OR HAVING ACCESS TO INFORMATION ENTAILING THE RECOGNITION SYSTEM WITH THE "RLS NO19."

LEADING ENGINEER: FOR WHAT IS THIS NEEDED, SUCH LISTS WE SORT OF HAVE NEVER COMPILED.

KIRPICHEV: I PUT THE SAME QUESTION TO "BALAN" BUT HE ANSWERED ME WITH NOTHING THAT WAS INTELLIGIBLE.

"BALAN NIKOLAY VLADIMIROVICH" - HEAD OF THE DEPARTMENT OF PROCEDURES (COMMENT: TRANSLATOR INTERPRETS "REZHIMIMAN" AS PROCEDURES).

DEPARTMENTS OF PROCEDURES ("REZHIMY") EXIST ON ALL SECRET UNDERTAKINGS. THESE DEPARTMENTS APPEAR TO BE BRIDGES CONNECTED WITH "VEN'YAMI" (COMMENT: WORD MEANING UNCLEAR), BETWEEN THE KGB AND THE UNDERTAKINGS (COMMENT: COULD ALSO BE ENTERPRISES). UNDER THE AUTHORITY OF THE PROCEDURES DEPARTMENT IS SITUATED THE BUREAU OF PASSES, THE PROCEDURES DEPARTMENT CONTROLS THE WORK OF THE FIRST DEPARTMENT, CARRIED OUT THROUGH THIS DEPARTMENT IS REGISTRATION OF ACCESS TO SECRET WORK FOR ALL CO-WORKERS OF THE INSTITUTE. ACCESS TO SECRET WORK IS CURRENT FOR TEN YEARS. ONCE EVERY TEN YEARS, ALL INSTITUTE CO-WORKERS FILL OUT QUESTIONNAIRES, HAND THEM INTO THE DEPT OF PROCEDURES, WHICH FORWARDS THE QUESTIONNAIRES TO CORRESPONDING ORGANS OF THE KGB. ORGANS OF THE KGB GIVE OUT PERMISSION FOR ACCESS TO SECRET WORK WHICH IS CURRENT FOR 10 YEARS. LAST TIME I FILLED OUT SUCH A QUESTIONNAIRE WAS IN 1980.

IN GENERAL THE PROCEDURES DEPT TOGETHER WITH THE DIRECTOR OF THE ENTERPRISE, IN ACCORDANCE WITH KGB INSTRUCTIONS, ARE OBLIGED TO PROVIDE SUCH A "REZHIMEN" (COMMENT: MEANING UNCLEAR) FOR THE WORK OF THE ENTERPRISE WHICH ELIMINATES THE POSSIBILITY FOR LEAKING SECRET INFORMATION. I SUPPOSE, THAT YOU WILL COME TO UNDERSTAND MY SITUATION AFTER I HEARD "KIRPICHEV'S" TELEPHONE CONVERSATION AND THE MESSAGE, WHICH HE GAVE THE LEADING ENGINEER; ABOUT PUTTING TOGETHER A LIST FOR THE PROCEDURES DEPT.

AFTER I LEFT THE HEAD DESIGNER, I PRACTICALLY COULD NOT WORK. AS RESULT OF FEVERISH ANALYSIS OF THE CONVERSATION, OVERHEARD IN THE OFFICE OF THE HEAD ENGINEER, THE ANALYSIS ABSOLUTELY HURRIED, BY THE END OF THE WORKING DAY, I CAME TO THE FOLLOWING CONCLUSION:

IN THE KGB IT HAS BECOME KNOWN THAT IN THE USA SECRET INFORMATION HAS COME THROUGH ON THE RECOGNITION SYSTEM, EMPLOYED ON THE AIRPLANE MIG-29 WITH "RLS NO19", BUT WHAT IS KNOWN IN THE KGB ABOUT THE ORIGIN OF THIS INFORMATION, I.E. IS IT KNOWN IN THE KGB FROM WHERE THIS INFORMATION PASSED? FOR A QUALITY ANSWER TO THIS QUESTION I TOOK TWO VERSIONS:

1. IN THE KGB IT HAS BECOME KNOWN THAT SECRET INFORMATION HAS BEEN PASSED ON THE RECOGNITION SYSTEM, BUT IT IS UNKNOWN FROM WHERE: FROM MOSCOW, FROM KAZANI, OR FROM SERIAL FACTORIES (GOROD RYAZAN', GOROD KHMEI'NITSKIY).

2. A COPY OF MY MATERIALS WAS MADE IN MORE THAN ONE EXEMPLAR AND WAS PASSED NOT ONLY TO ME, BUT ALSO TO SOME OTHER - FOR EXAMPLE REACHED THE KGB.

IF THE FIRST VERSION IS REALISTIC, THEN TO UNCOVER THE ORIGIN OF THE INFORMATION THE KGB NEEDS TIME.

SUBJECT: CKSPHERE OPS NOTE

IF THE SECOND VERSION IS TRUE, THE ORIGIN OF THE INFORMATION COULD BE DETERMINED IN ONE TO TWO DAYS. INDEED, ON 26 APRIL THE PROCEDURES DEPT WILL HAVE A LIST OF PERSONS WHO HAVE ACCESS TO SECRET INFORMATION ON THE RECOGNITION SYSTEM. MORNING OF 27 APRIL, THE PROCEDURES DEPT WILL PASS ON THE LIST TO THE KGB. IF THE KGB WILL HAVE A COPY OF MY MATERIALS FOR RECOGNITION, WRITTEN BY HAND, THEN TO DETERMINE THE AUTHOR OF THAT COPY THEY NEED ONLY TO COMPARE THEM WITH THE QUESTIONNAIRES ACCORDING TO THE LIST PROVIDED BY THE PROCEDURES DEPT. QUESTIONNAIRES, WRITTEN BY HAND AND FORWARDED TO THE KGB TO GET APPROVALS FOR SECRET WORK ARE STORED AT CORRESPONDING KGB ORGANS. FOR AN APPOINTED PERSON TO COMPARE THEM TO MY APPEARANCE, SEVERAL HOURS WILL BE ENOUGH.

THUS, I DECIDED, THAT ON THE 27TH AND BY THE LATEST, 28 APRIL, THE KGB WILL KNOW THE NAME OF THE PERSON WHO PASSED THE INFORMATION ON THE RECOGNITION SYSTEM. I HAD NO OPPORTUNITY TO GET TOGETHER WITH YOU TO DISCUSS THE SITUATION THAT WAS CREATED, SUCH THAT I EXPECTED THAT BY 28 APRIL THE OUTCOME (DENOUMENT) WAS TO COME.

TO THAT SITUATION, BY THE END OF WORK 26 APRIL I DECIDED:

1. TO DESTROY ALL THE COMPROMISING MATERIALS, WHICH ARE IN MY POSSESSION AT HOME.
2. TO TAKE ON ALL MEASURES, SO THAT I WOULD NOT FALL INTO THE HANDS OF THE KGB ALIVE.

IN MOSCOW TO DESTROY ALL MATERIALS QUICKLY AND WITHOUT

NOTICE PROVED TO BE A COMPLICATED MATTER. NOW FOR TWO YEARS WE ARE RENTING A HOUSE IN THE COUNTRY (80 KM FROM MOSCOW), WHERE WE GO FOR THE SUMMER PERIOD. IN THIS HOUSE IS A LARGE RUSSIAN STOVE, IN WHICH I DECIDED TO DESTROY EVERYTHING THAT I HAVE. I REACHED AN AGREEMENT WITH THE HEAD OF THE LABORATORY, THAT ON 27 APRIL I WOULD NOT GO TO WORK AND ON THE MORNING OF 27 APRIL, AFTER MY WIFE AND SON LEFT HOME, I GATHERED EVERYTHING:

[REDACTED] DEAD DROP INSTRUCTIONS, SIGNAL "SVET", BOOKS, MONEY AND LOADED IT INTO THE CAR, DROVE IT TO THE COUNTRY AND BURNED ALL OF IT IN THE RUSSIAN STOVE. METAL AND OTHER REMAINS, WHICH DID NOT BURN, I TOOK WITH ME AND DISCARDED THEM ON THE RETURN ROAD TO MOSCOW.

I DESTROYED EVERYTHING EXCEPT THE MEETING SCHEDULE, WHICH THE EVENING OF THE 27TH I ENCRYPTED INTO THE MAGAZINE "NAUKA I ZHIZEN", AND AFTER THAT DESTROYED THE SCHEDULE AS WELL.

I WELL UNDERSTAND THAT IF THE KGB HAS COPIES OF MY MATERIAL ON RECOGNITION, THEN MY MEASURES WOULD HELP ME, BUT ON THE OTHER HAND:

1. IF I SUCCESSFULLY DO AWAY WITH MY MATERIALS IN TIME, THEN THE KGB WILL NOT BE ABLE TO FIND DOCUMENTARY EVIDENCE OF MY RELATIONSHIP WITH YOU.

2. IF MY FIRST VERSION ABOUT THE SOURCE OF THIS INFORMATION PROVES TRUE, THEN SOME TIME IN THE FUTURE I CAN EXPECT THAT THE KGB WILL DECIDE TO CONDUCT A SEARCH OF PERSONS ON THE LIST PASSED TO THE KGB BY THE PROCEDURES DEPT. IN THIS CASE, THE KGB WILL NOT FIND IN MY APARTMENT NOR AT THE HOUSE IN THE COUNTRY, ANY COMPROMISING MATERIALS, I.E. I DECIDED THAT THE SECOND VERSION WAS REALISTIC, SO AFTER I RETURNED FROM THE COUNTRY ON 27 APRIL, I BEGAN TO RETHINK THE PROBLEM OF HOW NOT TO FALL INTO THE HANDS OF KGB AGENTS ALIVE. I WILL NOT DESCRIBE ALL THAT ENTERED MY HEAD REGARDING SITUATIONS OF MY ARREST. I WILL SAY ONLY THE FOLLOWING: TILL 27 APRIL 1983 I CARRIED [REDACTED] AMPULLE IN TWO CASES:

- WHEN I WENT OUT FOR A MEETING WITH YOUR CO-WORKERS,
- WHEN I TOOK OUT DOCUMENTS FROM WORK TO PHOTOGRAPH THEM.

THE OTHER TIMES I HAD [REDACTED] HIDDEN AT HOME.

ON THE 28 APRIL BEFORE GOING TO WORK, I TOOK OUT THE AMPULLE [REDACTED] PLACED IT IN MY POCKET SO THAT IT WOULD BE POSSIBLE TO GET IT QUICKLY. MOREOVER, I DECIDED THAT THE MOST PROBABLE PLACE FOR MY ARREST WOULD BE THE OFFICE OF THE HEAD DESIGNER. FOR EXAMPLE, THE HEAD DESIGNER WOULD SUMMON ME, I GO, OPEN THE DOOR TO THE OFFICE (THE DOOR OPENS TO THE INSIDE OF OFFICE) AND FROM BEHIND THE DOOR

AGENTS WOULD COME WHO WOULD GRAB MY HANDS WHEN I WOULD LEAST OF ALL EXPECT IT. THEREFORE, FOR THE NEXT SEVERAL DAYS WHEN THE HEAD DESIGNER SUMMONED ME, I PLACED THE AMPOULE UNDER MY TONGUE BEFORE I WENT TO HIS OFFICE.

I AM WRITING THIS MESSAGE AT THE BEGINNING OF SEPTEMBER. FROM THE 26 APRIL MORE THAN FOUR MONTHS HAVE PASSED AND IN FRONT OF ME TODAY AGAIN ARISES A QUESTION:

- IS THERE SOMETHING KNOWN IN THE KGB ABOUT THE INFORMATION LEAK ON THE RECOGNITION SYSTEM?

MY SECOND VERSION IS APPARENTLY GROUNDFLESS.

BUT THE FIRST VERSION MIGHT PROVE TO BE MORE REALISTIC. IT IS NOT EXCLUDED THAT THE KGB IS QUIETLY AND CAUTIOUSLY ATTEMPTING TO DESCEND ON THE TRAIL, WHICH WILL HELP UNCOVER THE ORIGIN OF THE LEAKED INFORMATION.

IN CONNECTION WITH THIS LAST I HAVE TO OCCUPY A WAITING POSITION AND LIMIT MY ACTIVITY IN COLLECTING INFORMATION. THUS, FOR EXAMPLE, I INTENDED TO CONTINUE DESCRIPTIONS OF WORK SYSTEM OF RECOGNITION IN THE DEPARTMENT (CONDITION? REZHIM) OF ESCORT, BUT FOR THIS GOAL I HAD TO TAKE FROM THE FIRST DEPARTMENT TOP SECRET DOCUMENTS WHICH ARE NOT NECESSARY IN MY SPECIALIZED (WORD UNCLEAR) WORK. NOW I MUST DELAY MY INTENTIONS FOR A MORE PROPITIOUS MOMENT.

2. IN THIS YEAR, WORKERS OF THE FIRST DEPARTMENT BEGAN TO CONDUCT THE FOLLOWING MEASURES: IN THE LABORATORY TWO WORKERS OF THE FIRST DEPARTMENT COME WITH A LIST OF EVERYONE WHO HAS TAKEN SECRET DOCUMENTS FROM THE FIRST DEPARTMENT. THEREFORE, THEY APPROACH CO-WORKERS ON THE LIST AND ASK TO SEE WHERE THE SECRET DOCUMENTS ARE LOCATED. IF A WORKER ON THE LIST IS ABSENT DURING THIS TIME IN THE LABORATORY, THEN THE WORKERS OF THE

SUBJECT: CKSPHERE OPS NOTE

FIRST DEPARTMENT ASK TO SEE HIS DESK AND CHECK TO SEE WHETHER THERE ARE ANY SECRET DOCUMENTS ON HIS DESK OR IN HIS LOCKED DRAWER. IF THEY DISCOVER SECRET DOCUMENTS ON HIS DESK OR IN HIS LOCKED DRAWER, THEN THEY TAKE THESE DOCUMENTS BUT THE WORKER, WHO HAS TAKEN THESE DOCUMENTS, IS LATER ORDERED BY ORDER OF THE DIRECTOR TO RECEIVE A WRITTEN REPRIMAND WITH THE WARNING THAT ANOTHER ACT WILL BE DEALT WITH BY STRONGER MEASURES. THIS YEAR THROUGH THE MONTH OF SEPTEMBER OUR LABORATORY WAS CHECKED FOUR OR FIVE TIMES. BESIDES THESE MEASURES BY OFFICERS OF THE PROCEDURES DEPARTMENT, THERE IS ONE MORE CHECK THAT WILL BE CONCLUDED IN THE FUTURE. TWO OFFICIALS FROM THE PROCEDURES DEPARTMENT WALK INTO THE LABORATORY AND UP TO ANY ONE OF THE ENGINEERS AND ASK HIM TO SHOW HIS DESK. THEN THEY CHECK ALL HIS NOTES IN HIS NON-SECRET NOTEBOOKS, COPY BOOKS, LOOSE PAPERS AND EVALUATE THE CONTENTS TO SEE IF IT CONTAINS SECRET MATERIAL.

I READ THE ORGANIZATIONS ORDER WHERE WAS ANNOUNCED A REPRIMAND FOR THE LEAD ENGINEER THAT HE HAD SECRET NOTES ON SOME OF HIS LOOSE, NON-SECRET PAPERS. (CKSPHERE COMMENTS: SUCH NOTES ARE SOMETIMES MADE BY ENGINEERS SO AS NOT TO TAKE OUT AN ADDITIONAL TIME A DOCUMENT FROM THE FIRST DEPARTMENT.) THIS ORDER APPEARED AFTER A RARE RAID ON THE LABORATORIES BY WORKERS OF THE PROCEDURES DEPARTMENT. ONE MORE FACT. A MONTH AGO, ALL CO-WORKERS OF THE INSTITUTE HAD TO SUBMIT TWO PHOTOS FOR NEW PASSES, I.E., A CHANGE IN THE PASSES IS IN THE WORKS.

3. THIS IS THE SITUATION THAT HAS BUILT UP FOR ME AT WORK AT THE CURRENT TIME.

THE CHECKS WHICH THE WORKERS OF THE FIRST DEPARTMENT AND PROCEDURES DEPARTMENT BEGAN IN THIS YEAR AND THE CHANGE OF THE PRUPOSKS PERMIT, APPARENTLY ESTABLISHES SUCH CONDITIONS OF WORK UNDER WHICH IT WOULD BE POSSIBLE TO TRACE THE LEAKS OF SECRET INFORMATION. PERHAPS THIS WAS DONE WITH A PREVENTATIVE GOAL AND DOES NOT HAVE ANY CONNECTION WITH THE SECRET INFORMATION ABOUT RADAR SYSTEMS WHICH APPEARED IN THE U.S.A. WHICH WAS PASSED BY ME.

IT SEEMS THE LIST OF PEOPLE HAVING ACCESS TO INFORMATION ON THE RECOGNITION SYSTEM, FOR ME, AN OPEN QUESTION. IN THIS COMPLICATED SITUATION I WAS FORCED TO TAKE MAXIMUM CARE AND IN THIS CONNECTION I WANT TO TELL YOU ABOUT MY PLANS FOR THE NEAR FUTURE. IN THE COURSE OF THE NEXT SEVERAL MONTHS I WANT TO REFRAIN FROM THE COLLECTION AND COMPILATION OF INFORMATION WHICH INTERESTS YOU. IF DURING THIS TIME THERE DOES NOT TAKE PLACE ANY UNTOWARD INCIDENTS, THEN RIGHT AFTER THE NEW YEAR I WILL BEGIN TO COLLECT FOR YOU MATERIALS IN ORDER TO PASS THEM AT THE NEXT MEETING.

ABOUT THE NEXT MEETING:

SINCE I WILL BEGIN TO COLLECT FOR YOU THE NEW MATERIALS AFTER THE FIRST OF THE YEAR IT WOULD BE EXPEDIENT TO SET THE NEXT MEETING FOR APRIL, 1984. UNLESS YOU FIND IT NECESSARY TO CHANGE THE MEETING SCHEDULE FOR 1984 AND TELL ME ABOUT THIS EARLIER, I SUGGEST THE FOLLOWING: THE NEXT MEETING WILL TAKE PLACE IN APRIL, 1984 (THE SECOND MEETING - 19.04.84 ACCORDING TO THE OLD SCHEDULE).

TEXT OF THE NOTE PREPARED FOR THE MEETING OF 21 OCT. 83. EVERYTHING, WHICH WAS WRITTEN IN THIS NOTE WAS PREPARED FOR THE MEETING TO WHICH I WENT IN SEPT. (20.09-SHMIT) ON THE FOURTH OF OCT. IT COULD NOT GO TO THE MEETING. TO THAT WHICH HAS BEEN WRITTEN I WOULD LIKE TO ADD THE FOLLOWING:

1. DURING THE LAST MONTH, ON THE BEHALF OF THE FIRST DEPARTMENT AND THE DEPT. OF CONTROLS (REZHIMQV), NO NEW CHECKS WHATEVER WERE CONDUCTED.

2. IF YOU PASS ME A NEW SCHEDULE AT TODAY'S MEETING, (21.10.83) THEN THE NECESSITY OF A DECEMBER MEETING WILL DISAPPEAR. IT IS POSSIBLE THAT YOU WILL NOT PASS ME A NEW SCHEDULE UNTIL AFTER YOU HAVE READ MY NOTE AND DECIDE THAT, UNDER EXISTING CONDITIONS IT DOES NOT MAKE SENSE TO CONDUCT A MEETING IN DECEMBER AND IN 1984 THE NEW EXISTING SCHEDULE WILL BE IN EFFECT. HOWEVER, I WILL NOT KNOW OF THE RESULTS OF YOUR DECISION, THEREFORE IN DECEMBER (17.12.83) I WILL COME TO THE MEETING.

UNFORTUNATELY COMMUNICATION BY TELEPHONE HAS BECOME PRACTICALLY IMPOSSIBLE. HERE IS WHAT HAS HAPPENED THE

TELEPHONE USED TO BE IN OUR KITCHEN. IN THIS CASE I WAS ABLE TO SIT BY THE PHONE WITHOUT ATTRACTING THE ATTENTION OF MY WIFE OR SON. AFTER MY SON ENTERED ARCHITECTURAL INSTITUTE, HE DEVELOPED A NEW CIRCLE OF FRIENDS AND BEGAN TO TALK LONG AND OFTEN ON THE PHONE. SINCE IT WASN'T CONVENIENT FOR HIM TO USE THE TELEPHONE IN THE KITCHEN, HE BEGAN TAKING IT TO THE OTHER ROOM. THE TELEPHONE CAN BE PLUGGED IN EITHER THE KITCHEN OR THE OTHER ROOM. I TALK ON THE TELEPHONE VERY SELDOM, MY WIFE OFTEN, THEREFORE WHEN SHE NEEDS TO MAKE A CALL, SHE TAKES THE TELEPHONE INTO THE KITCHEN AND, AFTER SPEAKING, SHE RETURNS IT TO THE OTHER ROOM. THAT IS, SOME KIND OF EXPLANATION ABOUT THE CALL I AM WAITING FOR IS NECESSARY. IT IS POSSIBLE TO TAKE THE TELEPHONE INTO THE KITCHEN BUT IT WOULD AGAIN BE NECESSARY TO SAY THAT I AM WAITING FOR A CALL AND THIS WOULD WARRANT AN EXPLANATION. 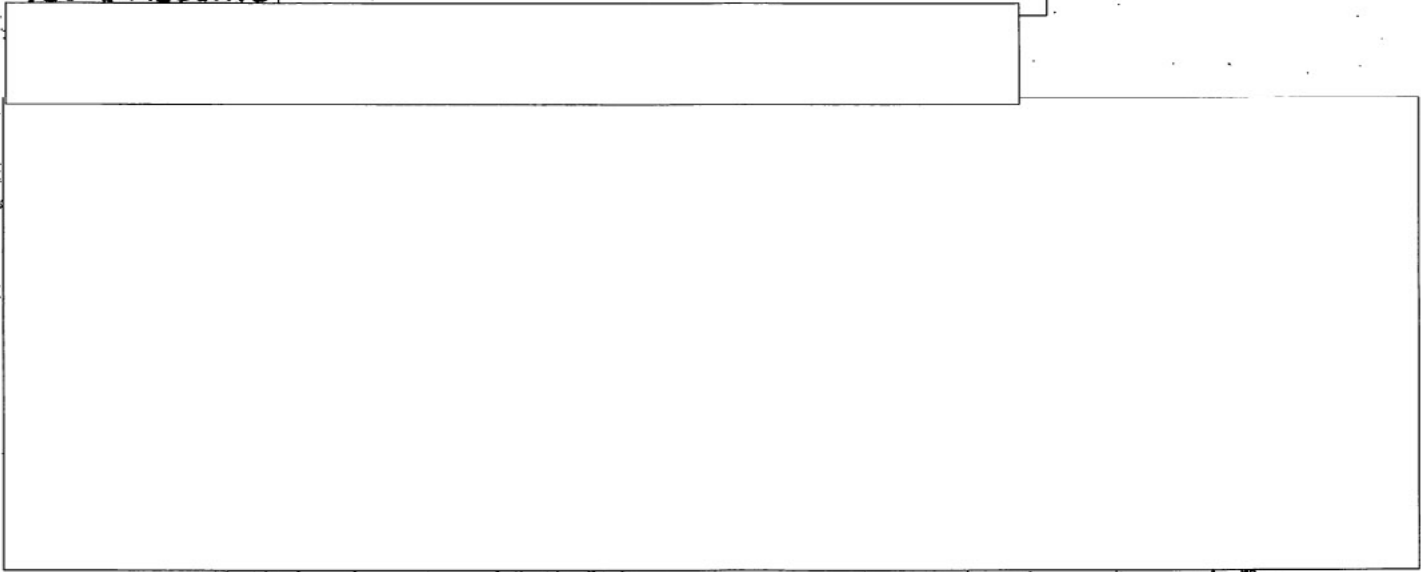

5. ABOUT THE COMPILATION OF INFORMATION:

IN CONNECTION WITH (WORD UNCLEAR) I WILL NOT BE ABLE TO PHOTOGRAPH MATERIALS, IT WILL BE NECESSARY FOR ME TO COMPILE ALL INFORMATION MYSELF AND WRITE IT OUT BY HAND. I AM ABLE TO RECORD SECRET INFORMATION ONLY IN THE EVENINGS AFTER WORK (SOMETIMES DURING THE DAY ON SATURDAYS AND SUNDAYS) AND ONLY IN THE LIBRARY. BUT OFTEN I CANNOT MANAGE TO GET TO THE LIBRARY FOR TWO REASONS. IN THE FIRST PLACE, AFTER WORK IN THE EVENINGS I OFTEN FEEL TIRED; IN THE SECOND PLACE, IT IS NECESSARY TO SOMEHOW EXPLAIN TO MY FAMILY WHAT I DO IN THE LIBRARY. OF CONTROL (REZHIMA) HAS BEGUN TO CARRY OUT CHECKS, DESCRIBED IN FULL ON PAGE NINE OF THIS NOTE AND THE MATTER IS BECOMING COMPLICATED. IN SUCH A CASE TWO SITUATIONS ARE ABLE TO ARISE. IF, ON THE NON-SECRET PAPERS I HAVE IS DISCOVERED SECRET NOTES WITH WHICH I WORK THEN I WILL GET OFF WITH A WARNING; BUT IF, ON THESE PAPERS, THEY DISCOVER SECRET INFORMATION WITH WHICH I DO NOT WORK THE MATTER MAY END ITSELF (WORD UNCLEAR). 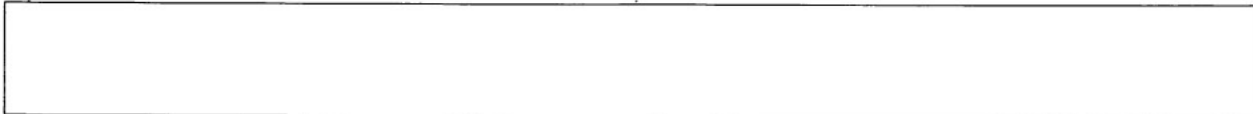
